PRESENTATIONS

National Merit Award Presentation to Sage Altman

During the board meeting, Dr. Davis presented the National Merit Award to Sage Altman, senior who achieved commendation as a National Merit Commended Scholar. This recognition places Sage among the top 50,000 entrants of the 2024 National Merit program based on her PSAT scores, distinguishing her within the top 3% of national participants. The award signifies not only a recognition of her academic achievements but also suggests promising opportunities for her future endeavors.

Blue Devil Hero Award Presentation

The meeting also included the Blue Devil Hero Award presentation, recognizing two exemplary staff members for their outstanding contributions to the school community. Amy Celis was acknowledged for her exceptional service, particularly noted for her supportive role among sixth-grade colleagues and her leadership in various school activities. Additionally, Craig Taylor, an intervention specialist, was celebrated for his dedication to inspiring and aiding both students and faculty, significantly impacting the school's environment and culture through his efforts.



Curriculum Adoption Presentation for Grades K-2

Jen McNeil presented the new ELA curriculum adoption (SAVVAS My View) for grades K-2, which aligns with the latest Science of Reading research. The curriculum was carefully selected through a rigorous evaluation process that included feedback from peer districts. It features engaging materials designed to be both teacher and student-friendly, with comprehensive resources supporting diverse learning needs. The curriculum encompasses high-quality mentor texts, explicit comprehension and writing instructions, and a robust assessment framework designed to monitor and support student progress effectively.

Social Studies Curriculum Presentation for Grades 4-6

Amy Celis provided an overview of the newly adopted Social Studies curriculum (Gallopade) for grades 4 through 6, focusing on its tailored content that addresses specific historical periods and geographical focuses as per Ohio's educational standards. The curriculum, designed to avoid the overwhelming breadth found in many other texts, offers a structured and engaging approach to learning history. It includes interactive components that integrate literacy skills, such as reading and writing, within the social studies context, making it a holistic educational tool that caters to the developmental needs of middle-grade students.

Curriculum Adoption Presentation for Grades 7-12

Nicholas Schaefer discussed the adoption of a new Social Studies curriculum for grades 7 through 12 (SAVVAS), tailored to meet Ohio's specific educational standards. This curriculum utilizes an interactive notebook format that combines text with engaging activities such as graphic organizers and written responses, making it suitable for younger learners. The blend of digital and physical resources allows for a flexible teaching approach, accommodating various instructional strategies and enhancing the learning experience across different grade levels. In addition to this, the Dave Ramsey Foundations in Personal Finance curriculum was selected for its comprehensive approach to teaching Financial Literacy, emphasizing the psychology and skills of managing money effectively. It combines foundational knowledge with real-world applications, helping students understand the importance of financial behavior and decision-making.

BOARD COMMITTEE UPDATES

Building & Grounds – Meeting was held prior to the board meeting this evening.

Discussions focused on ongoing activities and maintenance at the Central and Hilltop facilities which are currently used for youth soccer programs. The committee reviewed the upkeep of these facilities, including basic repairs and the potential for further improvements, such as field leveling. The committee discussed adding surveillance cameras to monitor the areas, particularly in response to recent vandalism at the Chad Richmond Memorial Basketball Court. Additionally, discussions regarding updating the contract for the Veteran's Memorial Stadium to ensure it remains a viable venue for school and community events, alongside necessary repairs to address issues like concrete sealing to prevent leaks. Future meetings are planned to finalize these initiatives and continue enhancing the facilities for community and school use. Next meeting scheduled August 7, 2024 at 4:30 p.m. in the Media Center.

2024-2025 Calendar (Late Arrival for RJSH)

Dr. Davis introduced a proposal to implement delayed starts four times per year for grades 7 through 12 to enhance collaborative opportunities among the teaching staff. These two-hour delays are intended to provide dedicated time for staff to focus on student data, instructional practices, and student wellness, which are crucial but difficult to address during regular school hours due to packed schedules and post-school responsibilities. He emphasized that such a schedule adjustment would facilitate more effective teamwork and professional development without the logistical challenges posed by early releases. The proposal is designed to be included in the academic calendar well in advance to allow families to prepare, with the aim to significantly improve the educational environment and outcomes.
