PRESENTATIONS

Strategic Plan Presentation

Mr. Tom Burton and Dr. Mari Phillips introduced the District's Strategic Plan, a visionary guide that will lead the district toward 2030. The plan is built around five central pillars: Academic Excellence, Inclusive School Culture & Climate, Communication & Family, Community Engagement, Health, Safety & Wellness, and Finance & Stewardship. Key initiatives include personalized learning pathways tailored to individual student needs, deeper integration of technology in classrooms, stronger community partnerships, and career development for students. This forward-looking plan is designed to prepare students not just for the next steps in their education but for a future in a rapidly evolving world.

Development Process

The Strategic Plan was developed through a comprehensive and inclusive process beginning in 2023. Stakeholders including; board members, students, parents, staff, and community members were actively involved through surveys, focus groups, and collaborative sessions. The process involved several phases:

- 1. **Pre-Engagement Meetings**: Initial discussions in November 2023 laid the groundwork for the Strategic Plan, setting the rationale and goals.
- 2. **Assessment and Analysis**: From January to March 2024, surveys and focus group interviews collected insights from over 340 stakeholders. This included meetings with building administrators, staff, students, and families.
- Strategy Formation and Plan Development: In May and June 2024, the Strategic Planning Team
 refined the district's vision, mission, and goals. Strategies were prioritized based on their
 feasibility, impact, and alignment with district objectives.
- 4. **Finalization and Presentation**: By August 2024, the plan was finalized after incorporating stakeholder feedback and presented to the Board of Education. Public hearings allowed community members to provide input before the plan's official adoption.

This Strategic Plan serves as a living document, guiding the district's actions and decisions over the next five years. The ultimate goal is to achieve educational excellence and enhance student outcomes.

BOARD COMMITTEE UPDATES

Building & Grounds - Next meeting scheduled November 6, 2024 at 4:30 p.m. in the Media Center. The Building and Grounds Committee, led by Crystal Menner, met at 4:30 before the Board Meeting. Discussions covered ongoing renovations and maintenance concerns at the Hilltop Athletic Complex. This includes a paving project which bidding is due on September 13, 2024 and potential options for installing security cameras at the Hilltop Athletic Complex. Both projects are partnered with the City of Reading and the district. The committee discussed the stadium lease agreement and major repairs at the stadium. The committee also discussed Central soccer field and the needed leveling to enhance conditions of the field. Finally, an update was provided about the Career Technical Grant project and the design of an innovation space in the building. VSWC Architects is leading the project.

The partnerships with local businesses continue to grow, providing students with invaluable hands-on learning experiences and pathways to
